Board of Directors' Meeting January 9, 2025 Minutes

1.00 - Call to Order

The meeting was called to order by Superintendent J. Schoonover at 1:12 PM.

2.00 - Minutes of December 12, 2024

The minutes of December 12, 2024 were presented for review and approved.

3.10 - Post-Employment Benefits (OPEB) Trust

Director of Finance, Jennifer Bouchard Prendergast noted the current OPEB account balance at the end of November is \$275,000. As of December 1, the Capital Reserve balance is \$119,000. SCEC's current OPEB liability is \$9.1M.

3.20 - Updating of the FY 25 Business plan/Budget

Director of Finance, Jennifer Bouchard Prendergast reports that November had a profit of \$145,000, partially due 2 less payroll days. SCEC has a year-to-date loss of \$48,000 and will continue a spending freeze on non-essential items.

SCEC is still in the process of hiring additional staff and will continue to monitor the student/staff ratios. Currently, SCEC has 207 staff. SCEC budgeted for 15 individual aides and as of December, 24 individual aides are required.

SCEC's student numbers at the end of November are 215 with our budget set at 225. As of January 9, 2025, 218 students are attending.

Currently, the Business Plan/Budget model being considered reflects 5% increases in tuition and other fees for services. All possible avenues are being considered and explored to reduce the potential increases, but as indicated major challenges exist. As always predicting student enrollment, the level of student

challenges, acquiring suitable public-school classrooms, and medical insurance costs are the most significant factors. Unfortunately, recruiting and retaining high quality staff and space issues are becoming increasingly difficult, and these issues are limiting program development efforts.

The Department of Education will conduct a financial audit this year at SCEC.

The SCEC Executive Director, David Heimbecker is happy to be part of this book club and feels it is a valuable part of the Board Meetings.

9.32 -According to Yuval Noah Harari in his latest book entitled *Nexus: A brief history of information networks from the stone age to AI* (2024) information and its use have been powerfully impactful throughout the history of the human species. The source of the power is seen by Harari in the potential to use information to self-correct. He believes that in sustainable institutions self-correction is built into the core of the organization and the use of it is celebrated. In this sense, self-correction is an ongoing process.

Harari (2024) also believes that there are Fundamental Principles that democracies can and should follow:

- 1 Benevolence- Information should be used to help me rather than manipulate me.
- 2 Decentralization A democratic society should never allow all its information to be concentrated in one place.
- 3 Mutuality-Surveillance of individuals should be balanced by surveillance of government.
- 4 Change and rest- must provide opportunities for both (pp. 311-315)

If outrage has become abundant, activism has become subdued. Are we so exhausted from our hashtags that we simply don't have the energy to be outraged in the real world? Or are we simply pretending to be bothered?

There is still much to be outraged by in our final frontier--the gender pay gap, racial bias, gun control--but to enact change, we must learn to channel our responses. Passionate, funny and unrelentingly wise, this is the essential guide to living through the age of outrage.
